4. FIRST AID MEASURES

Description of necessary first aid measures

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

- For non-emergency personnel** : Put on appropriate personal protective equipment.

Methods and materials for containment and cleaning up

- Spill** : Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). 7. HANDLING AND STORAGE

Precautions for safe handling

Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous.
